MATERIAL UNCERTAINTY RELATED TO GOING CONCERN AND EMPHASIS OF A MATTER BY THE INDEPENDENT AUDITORS ON THE GROUP'S FINANCIAL STATEMENTS FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2022

Pursuant to Rule 704(4) of the Catalist Rules, the Board of Directors (the "Board") of Katrina Group Ltd. (the "Company" and together with its subsidiaries, the "Group") wishes to inform shareholders that the independent auditors of the Company, Messrs Ernst & Young LLP (the "Independent Auditors"), have in their Independent Auditor's Report dated 13 April 2023 (the "Report"), included a Material Uncertainty Related to Going Concern and an emphasis of matter relating to the on-going investigation by the Urban Redevelopment Authority. The audit opinion in the Report however remains unqualified.

A copy of the Report, which includes key audit matters, and the extract note to the Audited Financial Statements are annexed to this announcement as Appendix I.

The directors are of the view that it is appropriate to prepare the Group's financial statements on a going concern basis on the following bases:

- (a) the Group will be able to generate sufficient cash flows from its operations to pay its liabilities as and when they fall due;
- (b) the management intends to manage cashflow of the subsidiaries on an overall Group basis, where necessary;
- (c) there are no changes in the Group's ability to request for the extension of credit terms granted by suppliers and the Group intends to adhere to the trade payables turnover days consistent with the current financial year; and
- (d) the controlling shareholder has indicated through a letter of undertaking to financially support the Group as and when required, for 15 months from 24 February 2023.

In relation to the on-going investigation by the Urban Redevelopment Authority, the investigation is still ongoing and no charges have been filed against the Group. The Group is cooperating with the investigation and will make further announcement(s) as and when there are material developments on this matter.

Shareholders of the Company are advised to read this announcement in conjunction with the Company's annual report for the financial year ended 31 December 2022.
